Councilor Brandon Briones asked Chief Ashe about 4 wheelers on city streets. Chief Ashe stated as long as the 4 wheelers or bikes are off road it is legal.

Councilor Justin Meyer asked Chief Ashe for more information on the racial profiling report. Chief Ashe stated it is a breakdown of all citation stops.

7. Update on the City of Kenedy projects with Hanson Professional Services.

GIS Data Collection- Ongoing data collection in progress. 75% complete –field training of water department staff in progress during data collection. Estimated 4-6 weeks to complete general data collection.

TCEQ Reporting - TCEQ cleared outstanding violations in January regarding water treatment plant repairs, operations manual revisions, and certain capacity requirements. Outstanding concerns include a corrosion study for the water treatment system, updates to the monitoring plan, ongoing documentation organization for pending CCI, and design plans for elevated tank and pumping to meeting additional capacity requirements.

Wastewater System- Freeny Lift Station: Pre-Construction Meeting is scheduled for February 20th. Expect Construction to begin either late February or Early March depending on when the contractor can mobilize. Wastewater Treatment Plant Improvements: Pre-Construction Meeting is scheduled for February 20th. Expect Construction to begin either late February or Early March depending on when the contractor can mobilize. Wastewater Treatment Plant Improvements Phase II: Received Mixer layout from manufacturer, waiting on spec information. Hanson is currently working on plans and specifications. Chemical Storage Cover: Draft plan set is ready for QC review. This project may be incorporated into the WWTP Phase II for bidding.

Water Treatment Plant and Distribution System Upgrades- WTP annex office: minor changes needed to the civil plans for the 60% set to be completed prior to submittal to Director for review. Brine Line initial work complete, with a change order to add concrete manholes around air release valve risers in progress. Change Order authorized by City on Monday. R.O. Train C pre-booster pump replacement bid opening scheduled for 2/27/2019. Ongoing design for high service pumps currently in progress. Critical path waterline replacement scope has been identified with the water department. This scope and a performance specification for bid will be discussed with the City ensure that TCEQ required tanks can be constructed with minimal disruption to the water system.

East Main St. Drainage/SS Repairs- Date of kick-off construction meeting set for the

end of February. Finalizing sanitary sewer design to be submitted for pricing. Expecting an updated construction schedule from the contractor.

The inspector for Bureau Veritas stated the owner of the property was asked permission to conduct a life and safety inspection on October 17, 2018. On October 22, 2018, the inspection was done and failed. There were 12 items that were against the Residential Code. 51 photos were taken. Jaime Albiar stated on December 18, 2018, he received the certified letter sent to owner unclaimed. On January 4, 2019, emailed the Countywide newspaper the notice to put in the paper. February 1, 2019, the second certified letter was sent back unclaimed as well.

Councilor Leslie Wynn asked if the house is safe. The Bureau Veritas inspector stated it is not safe. Mayor James D Sutton asked if this is a risk for others around. He stated yes it is. Councilor Brenda Cano asked where will the owner be housed if in violation. City Attorney Megan Santee stated the City will have to pay housing expenses.

Councilor Leslie Wynn stated Code Compliance needs a more thorough plan.

City Manager Barbara Shaw asked for authorization to execute a contract for a Street Sweeper in the amount of \$101,194.00. She stated the City is in dire need of getting our streets cleaned and will help with maintenance of new streets.

Councilor Leslie Wynn stressed the importance of training employees on new equipment. Barbara informed the Council that Kinloch will train all employees on new equipment.
