Opening Agenda

1. Call Regular City Council meeting to order.

The Regular Meeting of the City of Kenedy was called to order by Mayor Baker at 6:00 p.m. on Tuesday, June 08, 2021, in the City Auditorium in the Ruhman C. Franklin Municipal Building, 303 W. Main St. Kenedy, TX and video streaming via Facebook live.

2. Call Roll and establish a quorum is present.

With all Council Members present a quorum was established.

3. Prayer.

Pastor Trey Hill of The Word Fellowship Church led the prayer.

4. Pledge of Allegiance.

Mayor Baker led the Pledge of Allegiance to the U.S. flag.

5. Citizen comment.

There were no citizen comments.

6. Departmental Reports.

Public Works Director Report

Jerry Higgins addressed the Council to report the Public Works Director report. The WWTP and RO staff schedule has been adjusted to a 7 day, 8 hour work week. Continue to work on SEP documentation for phase II at the WWTP. On going correspondence with TCEQ concerning past agreed orders and violations are needing verification and just awaiting on response. Jerry Higgins has obtained his Noncommercial (Political) Pesticide Applicator License (Vector).

Police Chief Report

Chief Ashe addressed the council to report the Police Chief report. Chief Ashe stated no emergency management issues. Animal Control division is currently operating with one staff member. The animal control report was given and there was a total of 34 service calls for May. The Kenedy ISD is now out and the School Resource Officer is working park patrol on various hours and days. The game room in town was closed as part of a larger investigation into gambling and money laundering. Sgt. Barrientez completed the Texas Police Chiefs Leadership course based on the West Point model.

Building Department / Code Compliance

City Manager Linn addressed the council to report the Building Department report. There was a slight decrease in utility permits due to rain for the month of May. There was a total of twenty-three residential and commercial permits. There was a total of seventeen residential and commercial inspections. The department remained active in the community and increased the number of violations and warning letters for a total of fifteen. There were two commercial plans submitted to Bureau Veritas for approval.

City Manager Linn reported the Code Compliance report. There was a total of four cases closed, eight warnings issued, and fourteen active cases. Two liens were filed this month.

Streets & Parks Director Report

Director Parks & Streets Joe Hernandez addressed the council to report the Parks and Streets reports.

The parks crew worked for twenty days dragging/sweeping, twenty-four days removing trash from receptacles, and eight days weed trimming the fields. In addition, the crew mowed, weed trimmed, and picked up trash around the walking trail, basketball courts, bridge, and gazebo. During the month of May, the complex hosted thirty-eight Little League games, five Kenedy High School and Middle School games, and thirteen High School Playoff games for both baseball and softball.

The streets crew worked on hand patching/grading 75.1 cubic yards of Type D Asphalt, patching nighty-eight pot holes using 38.2 cubic yards of Type A Asphalt, worked on drainage using 23.1 cubic yards of base and five bags of cement, swept, and mowed/trimmed thirty-eight roadways and ally ways during the month. The crew installed one sign and repaired four. Crews worked on the parking entrance of the park. In addition,

Councilor Parker seconded the motion. Motion carried unanimously.

Mayor Baker requested an agenda item to be placed on the July 12 regular city council meeting for a presentation by Clay Wiatrek with Asset Protection Group. Clay reached out to let the Mayor know that his company offers services to help cities such as Kenedy protect their infrastructure assets. Since the city will see major changes and major investment in its infrastructure over the next few years, Mayor Baker thought it would be a good idea for the council to hear the presentation and have an opportunity to ask questions about what the company has to offer.
